This envelope contains your Marriage License, a Social Security form **TO BE RETURNED TO YOUR LOCAL SOCIAL SECURITY OFFICE** in order to change an applicant's last name, and a form for any additional proof of marriage copies you may need.

I would like to take this opportunity to extend my very best personal wishes to you, your families, and your friends upon this happy occasion.

*All applicants must be married in Ohio. Residents of Lucas County can be married anywhere in the State of Ohio. Applicants living outside the state of Ohio must be married in Lucas County.*

The enclosed Marriage License is in two sections. The entire Marriage License should be given to the person who will officiate your wedding ceremony. The License should have been signed by a Deputy Clerk. The top section, with the gold seal, will be given back to you by the Officiant and becomes a keepsake. The bottom section (Marriage Certificate) will be completed by the person who solemnizes your marriage and that person is responsible for returning this section to the Lucas County Probate Court in the brown envelope provided.

At the time you purchased your Marriage License, you also ordered one or more certified copies of your Marriage Certificate. The copy (or copies) will be mailed to you and is your legal proof of marriage. Should you ever need additional copies, you can use the enclosed form to request copies through the mail. You may also request additional copies in person at the Marriage License Department of the Lucas County Probate Court. Certified copies of the Marriage Certificate are \$2.00 each, payable in cash or money order only.

Contact your local Social Security Administration and Driver License Bureau with any questions or concerns about changing your last name.
